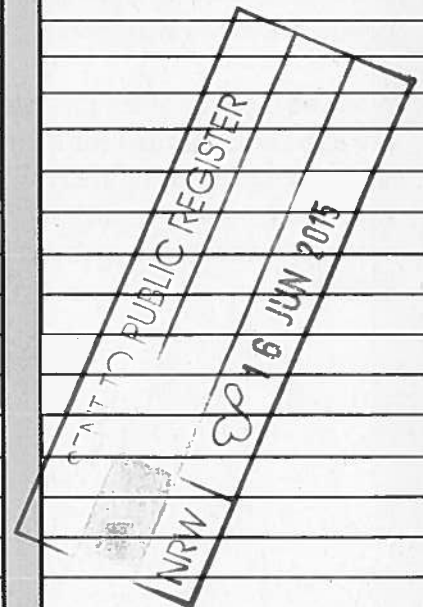

The Waste and Water 2015 annual report was received on 21st May 2015.

The amount of waste disposed of has not decreased, due to the disposal of unwanted materials prior to the building of the new extension and also due to increased production levels.

Waste handling methods and training have continued to improve. A photograph of the new waste compactor used to reduce the volume of used PPE and contaminated cloths was included in the report.

Poeton are very aware of their water consumption and make continued efforts to reduce it, including flow restrictor valves and turning off the supply to the rinses when they are not in use.

Usage will be monitored more effectively with the installation of a new flow meter and unexpected usage investigated more quickly.

Various improvements have been made to the effluent treatment plant, including a new flocculent dosing system and a filter on the cyanide pit for improved removal of cadmium and copper. Photographs of both were received with the report. In addition, the pH and redox probes are now subject to a regular service contract. Poeton will monitor the system to evaluate any improvements in their discharged effluent.

None of the improvements detailed above have been requested by Natural Resources Wales and Poeton are to be commended for their proactive attitude to resource use and waste control. We understand that waste generated is unlikely to decrease this year due the building and commissioning of the new extension, however, once the new premises are fully integrated into production, Poeton should review ways to reduce waste generation.
