The Waste Minimisation Report, 2017, was received on 1st June 2018.

The report is accepted.

The waste sent to landfill was 45% less than in 2016 and the amount of waste sent for recycling also fell by ~30%. The ratio of waste sent to landfill to waste recycled was 23% less than in 2016. Waste generated per operating hour and waste generated per employee reduced by almost 50%.

Overall water usage fell by 19% and water usage per operating hour and per employee fell by 24% and 28% respectively when compared with 2016.

A very encouraging report. Measures put in place in 2017 have obviously been successful and it is good to see that Poeton have plans to further reduce waste generated by the business.
