This unannounced site inspection was carried out on Tuesday 20th August 2019 by Natural Resources Wales officers Ross Briscoe (Senior Officer Industry & Waste) and Julie Hughes (Tackling Waste Crime Officer).

Accompanying officers throughout the inspection were operatives of the Civic Amenity site and representatives of Gwynedd Council.

Weather conditions throughout the visit were dry and sunny.

The site was operational with members of the public depositing waste into the correct waste receptacles. Operatives were on hand to assist the public with ensuring waste was placed within the correct container.

All waste material was appropriately stored. Site surfaces were clean and tidy.

No issues were noted relating to noise, dust, odour, litter, vermin or deposits on the highway.

A brief inspection of onsite documentation took place. This included site inspection checklists and documented procedures – no issues were noted.

Richard Hughes is the current Certificate of Technical Competency holder for the site. Richard's certification is currently up to date.

A brief discussion also took place around 'black bag' sorting at the site. Although undertaken in the past, this process is no longer carried out. Separate guidance is available via WRAP Cymru upon this.

No non-compliances were observed upon this inspection therefore the total number of CCS points recorded for site inspection on 20 August 2019 – 0.

Total number of CCS points for the 2019 compliance year so far is 0. This places you within compliance band A..
