This unannounced site inspection was carried out on Tuesday 20th August 2019 by Natural Resources Wales officers Ross Briscoe (Senior Officer Industry & Waste) and Julie Hughes (Tackling Waste Crime Officer).

Accompanying officers throughout the inspection was Rosalind Jones of S & R Metals.

Weather conditions throughout the visit were dry and sunny.

The site was closed upon arrival with the site gates securely locked. A site identification board was located at the site entrance. Officers proceeded into the site with Rosalind Jones through a side entrance door.

All waste material was appropriately stored with site surfaces clean and tidy.

A small number of ELV's were stored on site, no more than 10 in total. These were stored on a concrete pad towards the rear of the yard.

No recent activity had taken place on the site. Metal wastes were positioned suitably without causing concern.

No issues were noted relating to noise, dust, odour, litter, vermin or deposits on the highway.

Officers were advised that COTC cover is currently being provided by external COTC holders. Details of who is providing COTC cover on site is now required to be submitted upon the waste returns forms which you are required to submit annually in accordance with condition 4.2.2 of your permit..

Site documentation was not reviewed during this inspection.

A discussion concerning hazardous waste documentation took place – separate guidance will follow.

No non-compliances were observed upon this inspection therefore the total number of CCS points recorded for site inspection on 20 August 2019 – 0.
