Review of emissions reporting 2014 and 2015 YTD

Water - all measurements are within ELVs. It is noted that pH trends continue to be less than 7 sometimes approaching the lower ELV of 5.

Air - all measurements within ELVs. Recommend that temporary revision of CO concentration ELV is formalised when the IED permit review is carried out. Timing for this is currently uncertain, but is likely to be done upon conclusion of the Large Volume Inorganic Chemicals - Ammonia, acids and Fertilisers BRef rather than currently under the Refineries BRef.

Previous recommendation to include measurement uncertainty with the reported data should be implemented in future reports.

Energy efficiency report - permit condition 2.7.2

Approach to design process efficiency despite reduced demand is noted.

EMS report - permit condition 4.1.4

No 2014 or current year environmental improvement targets identified in the report. Consideration should be given to tracking water consumption, review of new burner NOx emissions performance, review of steam condensate loss rates.

Fugitive emissions report - permit condition 4.1.5

As previously requested this report should include quantification of hydrogen venting/flaring and reasons for venting/flaring.
