After introductions SG gave TW an site safety induction including a discussion of the computer system within the Control Room.

After the induction SG lead the group out through an internal side door into a room known as the "Dirty Kitchen" and then into the pedestrian area of the "Reception Hall".

SG gave the group an overview of the process (inc. hoppers, Grit tank, macerators – 25mm rough cut, and the feedlines).

The group then moved outside where SG commented on the presence of the underground channel.

As the group moved towards the Tank Farm GJ inspected the waste skips - all OK at time of inspection.

At the Tank Farm both TW and GJ made a positive comment about the signage (on all tanks) the group also had a discussion about the Raw Waste Buffer Tank, the outlet pipework (inc the macerators – 12mm screen size and the APHA sample point).

Then onto the Digester Tanks 1 and 2.

The pasteurizer, separator, and the Final storage Tank that is located on lowest pad.

The group walked up to the separator skip (newly fitted with a wind protector).

DSEAR discussion signage and viewed Container 1 – Control Room Boiler House and Container 2 - gas engine. And examination of the flare and associated pipework.

When returning to site office the group had a discussion about the provision of fire water and the potable water connection.
