4. Details of our assessment

An inspection at Tata Shotton was undertaken on the 02 November 2021 by Industry Regulatory Officer Berwyn Williams. This was mainly a physical site familiarisation visit following a "virtual" one carried out in December 2020 (due to Covid restrictions)

The following areas were inspected below:-

Project Cobra

A presentation was given on the considerations to change the set-up by removal of the RTO. This will require an application to vary the permit. Trials have taken place both in 2019 and June 2021, the data suggests the by-pass directly into the stack and removal of the Regenerative Thermal Oxidiser (RTO) may still keep them within ELV permitted levels. Submissions for variation to be done as soon as possible, however considerations for compliance whilst determination is carried out has been raised.

Tern Lagoon

A presentation on the project set up and updates on the works to the Tern lagoons was given. This was then witnessed during the drive around the site.

ETP

Visual inspection and walk through of ETP were carried out during the drive around the site.

There are no non compliances in respect to any of the above, and the site is compliant with the permit requirements in permit (BR7321IK).
