4. Details of our assessment

An inspection at Tata Shotton Landfill served as part of the overall site inspection

undertaken on the 02 November 2021 by Industry Regulatory Officer Berwyn Williams. This was mainly a physical site familiarisation visit following a "virtual" one carried out in December 2020 (due to Covid restrictions)

The following areas were inspected below:-

The tipping face and cells still under consideration for use were visually inspected, no use of Gazomat on this inspection and no current use of the landfill for any waste acceptance taking place during inspection.

There are no non compliances in respect to the above, and the site is compliant with the permit requirements for the emissions monitoring programme requirements in permit (GP3030BE).
