Q3 Monitoring Returns (W1) 2021

Emissions to water (inc Effluent Plant Water) data for Q3 2021 (July - September 2021) reviewed.

Emissions from W1 tested for Flow, pH, Suspended Solids, COD, Iron, Chromium, Mercury, Nickel, Zinc and Ammoniacal Nitrogen. Noted that all measured parameters are below permitted emission limit values (ELV).

Effluent discharge tested for pH, Iron, Mercury, Chromium, Nickel and Zinc. There are no permitted emission limit values associated with the effluent.
