Officers Jonathan LEE and Richard PALMER visited Volehurst Limited, Newport to complete a site inspection of permit **EPR-KP3595FB** and to obtain an update on the non-compliances identified during the previous inspection. The previous inspection of the site was completed by Richard PALMER on the 6th June 2018. This inspection listed three Category 4 breaches, with details of action to be taken and deadlines for completion. Officers met with owner of the site Mr Mike Webb. The weather was cold and sunny.

Inspection

The mechanical and hand sorting of waste on site was being completed on the area of impermeable surface. Waste types on site mostly comprised of soil/stones from the construction industry, wood, plastics, metals and general skip waste. Mr Webb gave details on the sites operations, most waste is transferred to Newport landfill after being sorted on site.

Previously outstanding waste returns for Q2 of 2018 have been retrospectively submitted. The returns for the most recent Q3 of 2018 have also been submitted. Thank you for completing these returns and submitting them in a timely manner, please continue to do so.

Breaches

C1 – Staff Competency and Training – Permit Condition 1.3.1 Category 4 Breach

It was noted during the previous visit that the Technically Competent Manager for the site, Mr Kenneth Webb, did not have a certificate of continuing competency. It was noted on site that Mr Kenneth Webb had failed the test earlier in October and was due to re-sit the test.

Action: Please ensure that a suitable re-test is booked and send evidence of continuing competency (once exam is completed).
