Odour Incident of 12th August 2015 (Ref: 01363826)

An NRW Officer attended the Mwyndy area at around 14:50 hrs.

Odour was detected on dual carriageway near turn off for Maxibrite and at Mwyndy Cross. The officer drove to Maxibrite entrance. The site was operating, and heat haze could be seen from the top of stack indicating that the process was running. The haze appeared to be blowing westward indicating easterly winds. Winds today are light, with stronger gusts. Met Office shows E.N.E winds which is consistent with my findings. Site had recently dampened down roadways to suppress dust. This is good practice.

Another report of odour (ref 01363999) was received on 13th of August. This incident was not verified by an NRW officer.

A minor non-compliance (Category 3) has been recorded for the incident on the 12th August.
