Recent complaints of odour and dust

Three complaints have been received recently, summarised as follows:

18th November - odour (ref: 01295303)

19th November - odour (ref: 01295715)

20th November - odour & dust (ref: 01295948)

28th November - odour (ref: 01297962)

I have attended the Mwyndy area on some of these occasions and noted transient odours for the most part, depending on wind conditions. In addition, on the 20th November, I collected a dust sample from a windowsill at a local residential property in Mwyndy. The visual analysis of the sample via microscope indicated the likely presence of coal dust. This is based on a comparison with a "control" sample taken from Maxibrite on 9th May 2013.

On the 28th, I attended the area and I witnessed more pungent and consistent odour in the Mwyndy area, particularly along parts of the dual carriage way and Old Cardiff Road.

A non-compliance has been recorded for the dust event (20th November) and the substantiated odour event (28th November).

With regard to dust, please review the current dust management arrangements with regard to BAT. Solutions such as fogging (fine water mist) could be employed during activities such as unloading or when coal fines are being moved. Options to prevent dust from tracking out of the site on vehicles should also be considered. The link to the BREF for Emissions from storage is given below.
