The installation of improved dust control such as the rain gun are commended. The ongoing stock reduction of coal fines is key to the overall management of dust and to reducing levels of particulate in the site water. The trialling of filter cloths for the effluent filtration is also noted. NRW hopes that the trial of the different cloths will be complete soon.

EMS

NRW acknowledges the Green Dragon Level 4 audit, which indicated that the EMS will be accredited for another year. This is commended.

Dust deposition totals. Data received on 30th June 2015.

Response to CAR of 26th June 2015, received on 10th July 2015

Progress on odour monitoring. The report showed a wide range of results, meaning that further monitoring is needed to characterise emissions from the process. The need to compare the results with process conditions is also recognised. NRW sent an email on 13th July suggesting that the monitoring frequency could be increased to allow for a more rigorous data set.

ACTION 1: Please provide an update on your proposals with regard to improving the odour monitoring data in the next monthly housekeeping report.
