As discussed during the recent visit, the permit will need to be reviewed together with other sites within the refining sector. NRW notes that the process Maxibrite operates may be compared with a number of different sectors, due to the shared issues such as dust management and emissions to air and water.

The remaining improvement conditions (IC4, IC5 and IC12) will be impacted by the latest standards and emissions benchmarks brought about in the sector review and will be assessed accordingly. Information from already completed ICs such as IC14 (A9 emissions) may be used in the review, together with data from monitoring returns and from IC4 (effluent treatment). NRW will contact Maxibrite to discuss the permit review in due course.
