Odour incidents of 1602670 & 1602682 (24 and 25th May 2016)

NRW attended the Mwyndy area at 10:45 on the 25th May. The site appeared to be operational and was busy with HGVs entering and leaving site. Odour was detected on the dual carriage way near the lane entrance, and on Old Cardiff Road from the BETS area down to the bus stop. The odour seemed fairly consistent for the short period of the visit. Easterly winds were noted.

Maxibrite confirmed that AMEC are undertaking the odour modelling work as part of an action plan. We have not scored a non-compliance on this basis. Please provide an update by the end of June.

In addition, black dust was seen to be tracking out (via HGV wheels) of the site which extended up the lane towards the dual carriageway. It is important that this is minimised to prevent wind-blown dust.

Maxibrite considered that that recent extra movement of raw materials (to reduce overall stock) may have contributed to this. Road sweepers are already in place. We have not scored a non-compliance on this basis, although further issues may be scored. Please consider what improvements are required during periods of high traffic and provide an update by the end of June.
