This CAR form is in response to recent groundwater monitoring results that are in breach of the trigger levels imposed at the site. No site inspection was carried out, this was a desk based study of the submitted results.

E2-Emissions -land and groundwater. A category 2 breach has been scored against permit condition 3.1.1 for the emissions of substances not controlled by emissions limits.

Within the monitoring round for November 2015 to May 2016, a series of breaches of the groundwater results have been identified. The elevations against the trigger levels are for several monitoring locations and were noted for ammoniacal nitrogen, TPH and PAH at varying levels. These substances are not normally found in the groundwater and due to recent findings within a site audit, NRW believe that the long term storage of soils and wastes that have not been stored or treated correctly to be the cause.

The pollution was identified within the results for WS7 (AN and TPH), WS11 (AN), WS13 (PAH) and WS14 (TPH and PAH).

These pollutant levels range in severity but it has been recorded that breaches of the trigger levels have been greater than double in some results and even up to 7 times over the allowable level. This is unacceptable.

ACTION: Please initiate an investigation into the causes of the groundwater pollutions and remove the cause from site. These are large breaches over the levels outlined within the permit and must be taken seriously.

Please note that the levels for the monitoring tested against that are detailed within Table S3.2 for Groundwater are not limits as referred to within 3.1.1. The levels that are tested against are 'other specifications' and so any breaches of these values are therefore classed as a pollution by a substance that is not controlled by an emission limit.
