### 4. Details of our assessment

Following a number of reports of dust emissions coming from Hanson Cement across the weekend of the 13/14th November, Officers attended site on Monday 15th November to carry out a site inspection.

The shift manager explained that on a Monday they employ a company to undertake

cleaning on the plant/conveyors and this appeared to be taking place when we were on site.

There was a large mound of clinker dust accumulated on the floor outside the G1 conveyor which appeared to have leaked out of the side of the building cladding. The shift manager was not aware of this prior to our inspection. They assured us that this would be cleared up within the next 24hrs and confirmed to NRW via email.

**ACTION:** Investigate the root cause of the spillage to avoid a recurrence and why the spillage had not been detected earlier on when the investigations into the complaints was undertaken that morning. Please provide a response by the 10th January 2022.

During our inspection there was no other areas noted that appeared to be causing a visible dust emission.
