On the 3rd January 2019 an odour complaint was received by NRW from local business relating to a potential odour from 2 Sisters Llangefni.

Condition 1.3.1

Without prejudice to the other conditions of this Permit, the Operator shall implement and maintain a management system, organisational structure and allocate resources that are sufficient to achieve compliance with the limits and conditions of this Permit

An investigation was carried out by site and a Schedule 1 notification received on the 8 January 2019. It appears that a Animal By Products (ABP) lorry arrived on site unclean and part laden with ABP waste which had the potential to cause offsite odour.

Further investigation detailed that the updated procedure to not allow contaminated trailers on site between the hours 08:00 - 18:00 had not been rolled out to staff. Procedure was changed on the 7 December 2018 as per email from Steve Jones to NRW on the same date.

As EMS procedure ENV2015 - 15 ABP Waste Handling Procedure revised on 7 December 2018 had not been rolled out, standard operating procedure on site was still not sufficient to stop contaminated ABP lorries arriving on site.

Breach of condition 1.3.1 - insufficient SOP for ABP waste handling, scored one category 3 score.

Action

Site to inform NRW upon completion of training for the rollout of ENV2015 - 15 APB Waste Handling by 5 February 2019.
