4. Details of our assessment

A routine inspection of M&R Commercials Vehicle Dismantling & Recycling Facility,

Fforest-fach, Swansea, SA5 4HL was carried out on 29/04/2021 by NRW Waste Regulation officers Linda Warrick and David Ellar. The site is operated under a SR2011 No.03 permit (EPR-GP3193MV).

NRW officers attended the site and were met later on in the visit by Mal Wiberg of M&R Commercials (TM Wiberg Ltd).

The weather in the days prior to the visit had been very wet and this was evident by the standing water on some parts of the site. The purpose of the visit was a routine general inspection, and follow up actions identified in a previous CAR (CAR_NRW0038037)

Actions to be followed up from previous CAR were:

1. Installation of interceptor and improvement of sealed drainage system
2. Oil storage must be stored with secondary containment
3. Wastes to be removed from the site boundary to the neighbouring Brenntag UK limited.

Installation of interceptor and improvement of sealed drainage system:

The new larger interceptor had been installed and improvement to the impermeable pavement had been completed. All surface water except for clean roof water was now connected to the interceptor.

Oil storage must be stored with secondary containment:

The open top IBC had been removed from site and oil was now stored in a double bunded tank in the garage.

Wastes to be removed from the site boundary to the neighbouring Brenntag UK limited:

Waste had been cleared from the boundary. This area was now being used to store aggregate for improvements to hardstanding areas.

Hazardous waste:

Several hazardous waste consignment notes were inspected and were found to be completed correctly. Copies of consignment notes for catalytic converters were requested but were unavailable for inspection.

ACTION: Please can copies of consignment notes for catalytic converters and batteries please be forward to site officer for inspection.

General observations:

There is a considerable amount of standing water particularly to the rear of the site. The operator acknowledged this was an issue and was planning future drainage works to address it.

Action: Please forward a plan of future drainage with with time scales to address standing water issue to NRW.
