This was an unannounced inspection carried out by regulating officer Steven White, Mike and Steve Jackson were both on site at the time of the visit but due to the busy nature of operations that day were unable to accompany round the site.

There was a lot of site activity during the visit, on discussion with Mike Jackson there has been deliveries of 12-15 cars daily in the past few weeks. You must ensure that once operational capacity has been reached that no further vehicles are accepted on site until there is room for them to be treated.

It was observed that there was a large number of tyres in various areas of the yard (see photo below), these will need to be removed as soon as possible; a collection has been organised for these.

There were 3x empty IBCs observed on the yard and one that was approx. 2/3 full of what resembled oil but was later claimed to be just dirty water.

There were several vehicles that had not been depolluted stored adjacent to the interceptor (they had fluids and batteries still in the engine block, see photos below), these were waiting to go into the garage for depollution. You must ensure that these vehicles are depolluted and stored on the main yard as soon as possible.
