G D are planning a slight change in business direction. They will no longer be taking leachate from Docksway and have decided to use the treatment plant to increase their capacity for treating other non-hazardous waste. This will involve some modification of and investment in the existing plant.

The meeting was arranged so that the proposed changes could be discussed with Natural Resources Wales (NRW) and Welsh Water (DCWW) to ensure that the EPR permit and existing consent limits would not be breached.

The treatment volume (NRW) and discharge volume (DCWW) will need to be amended before the plant is fully operational.

G D must inform NRW in writing before they undertake commissioning trials or production runs on the modified treatment plant, complying fully with EPR Permit Condition 4.3.5.

GD propose to add the old OSS tank to the permitted area in the tank farm and use it for the same wastes.

Other, longer term, site developments were discussed and the queries raised will be dealt with separately as NRW believe the information is confidential at this stage of the process.
