A Schedule 6 notification was received on 4th January 2016. There had been an exceedance of the emission limit value (ELV) for particulates from emission point A6 on 21st December 2015. The ELV is 25mg/m³ and the measured value was 79.9 +/-3.44mg/m³.

A subsequent investigation by Kennametal and the manufacturer of the scrubber showed a build-up of material in the scrubber's mist eliminator. While this may not have been the cause of the exceedance, Kennametal will improve their maintenance procedures and operate the scrubber with the air intake valve open, as advised by the manufacturer.

Kennametal have been issued with a Cat 3 non-compliance for exceeding the ELV for particulates from emission point A6 and with a Cat 4 non-compliance for maintenance and operation of this scrubber.

Maintenance and operating procedures for all air abatement equipment will be audited later this year. In the meantime we hope that Kennametal will apply any lessons learned from this incident to their other abatement equipment.
