One of Kennametals's EMS targets for FY 2015 (ending June 2015) is to determine whether the large furnace pots can be recycled once their useful life is over. Smaller pots are already recycled, but there is more contamination in the larger ones and the recycling company are concerned that they might be classified as hazardous waste. Various ways of determining this were discussed. The easiest first step is to calculate the approximate percentage of hazardous material that the used pots might contain. If the calculation shows that the concentration might be close to the threshold of 0.5% then it may be necessary to analyse a representative sample. An initial calculation gave a result of <0.1%.

The planning consent for the company who take some of the graphite waste will be examined by Natural Resources Wales (NRW) so that we can determine exactly what they are allowed to do.

The information needed to determine whether another material meets end of waste criteria was also discussed. Kennametal are waiting information from a third party before submitting it to NRW so that the matter can be discussed in more detail.
