On 18th October 2017 Kennametal notified Natural Resources Wales of an exceedance of the emission limit value (ELV) for particulates from emission point A3. The emission occurred on 29th September 2017 and was measured as 9.8 +/- 1.5 mg/m³. The ELV for this emission point is 5mg/m³.

On inspection the HEPA filter in the filtration unit was found to be damaged. It was checked a week before the monitoring and found to be in a satisfactory condition. The interval between inspections for this filter has now been increased from monthly to weekly.

The Schedule 6 Notification and the proposed remedial actions are accepted.
