Two actions were requested as a result of the OMA audit of emissions to water conducted on 14th January 2015. An overview of the findings was given in CAR BX3376IG/0229723.

Action 1: Send revised calibration procedure and measurement method for lab pH meter to Natural Resources Wales (NRW) **by 6th February 2015.**

The revised procedure was received on 25th February 2015 and is accepted.

Action 2: Purchase new AAS standards for chromium, nickel and zinc and send copies of either the Certificates of Analysis (CoAs) or the Certificates of Conformity (CoCs) and specifications to NRW **by 27th February 2015.**

New traceable standards have been ordered and Continental Teves are awaiting their delivery. The CoAs will be forwarded to NRW as soon as they are received.

Actions 1 and 2 are now closed.
