Reporting forms S1, Emissions to Sewer; E1, Energy Usage; R1, Waste Disposal and Recovery; WU1, Water Usage and MR1, Mass Releases, for 2015, were received on 20th January 2016.

From the figures supplied it appears that production increased by almost 13% in 2015, compared with 2014.

Form S1, Emissions to Sewer, 1st January – 31st December 2015

All emissions were within their respective Emission Limit Values (ELVs).

The report is accepted.

Form E1, Energy Usage, 2015

Overall energy usage and consequent CO₂ emissions fell by 37% compared with 2014. When adjusted for the increased production the decrease was 44%.

This reduction is largely due to turning off extraction equipment when it is not needed. Exposure limits were not compromised by this action.

The report is accepted.

Form R1, Waste Disposal and Recovery, 2015

Total hazardous waste produced increased by more than 60% in 2015 compared with 2014. Non-filter cake waste was nearly three times more than that produced in 2014. Filter cake waste was 25% less than in 2014. These figures are slightly better when adjusted for production volumes, 45% more for total waste, 2.4 times more for non-filter cake waste and 34% reduction for filter cake waste.

The increases were due to the disposal of process solutions during summer shutdown and to the installation of other process solutions to accommodate a change in product mix later in the year. The decrease in filter cake waste was due to the improved performance of the filter presses.

The report is accepted.

Form WU1, Water Usage, 2015

Overall water usage increased by more than 35% and water used per unit increased by more than 20%, when compared with 2014. These increases were primarily due to the change in product mix in the latter part of 2015. Given the nature of this process, there is very little scope for further economies.

The report is accepted.

Form MR1, mass Releases, 2015

The calculated mass releases of cadmium and mercury increased when compared with 2014, due to increased production volumes. Both were less than their respective ELVs.
