The Environment, Safety and Health Overview report for 2015 was received on 29th February 2016. The report is accepted.

Targets set for reducing energy use and consequent CO₂ emissions were exceeded.

Unfortunately targets set for reducing water use and waste generated were not met and the amount of waste recycled also fell. This was mainly due to a change in product mix.

Effluent sludge volumes were less than in 2014 and achieved their target reduction.

Reductions in the use of cardboard boxes and wooden crates and pallets were achieved, but the ambitious target was not met this year. However, returnable packaging is being introduced with more suppliers, which should produce further reductions in 2016.

Freight utilisation is being rationalised and was reduced but did not meet the target for 2015.

The Fugitive Emissions review for 2015 was received on 7th April 2016. The report is accepted.

There were no fugitive emissions to any receptor in 2015. All surfaces, sub-surface structures, bunding and storage areas were in good condition. However, the chemical storage containers outside the building will be replaced during 2016 due to some external corrosion. This surface corrosion is minor and most unlikely to result in failure of the containers, which are also internally bunded. Continental Teves will be undertaking a further CCTV survey of underground pipework in the latter part of 2016.
