The annual reporting forms for 2017, S1 Emissions to Sewer, E1 Energy Usage, R1 Waste Disposal and Recovery, WU1 Water Usage and MR1 Mass Releases, were received on 2<sup>nd</sup> February 2018. All the forms are accepted.

### **S1 Emissions to Sewer, 1<sup>st</sup> January to 31<sup>st</sup> December 2017**

The mercury (Hg) emission was much higher in 2017 than in 2016. This was due to significantly reduced water consumption. The cadmium (Cd) release was similar to the previous year.

### **Production Volume**

This was 10% lower than in 2016.

### **MR1 Mass Releases 2017**

The Hg mass release was similar to 2016. The Cd release was approximately half of that in 2016.

### **WU1 Water Usage 2017**

Total usage reduced by more than 30% compared with 2016 and usage per unit of production fell by 25%.

### **R1 Waste Disposal and Recovery 2017**

Total hazardous waste generated was 20% less than in 2016 and waste generated per unit of production fell by almost 11%. Filter cake waste was 12% less than in 2016 and was 2% less per unit of production. Other hazardous waste generation fell by 25% in 2017, equating to 16% per unit of production.

### **E1 Energy Usage 2017**

Total primary energy used and CO<sub>2</sub> generated were similar to 2016. The amounts of energy used and CO<sub>2</sub> generated increased by 11% per unit of production.

Continental Teves are to be congratulated for their significant reduction in water consumption and waste generation this year. Savings in energy consumption is perhaps an area that could be investigated in 2018.
