This meeting was arranged to explain how Natural Resources Wales (NRW) regulate installations permitted under the Environmental Permitting Regulations 2016 and other relevant legislation. Continental Teves have recently employed a new EHS and Site Services Co-ordinator as the previous incumbent will be retiring soon.

### **Present at the meeting**

Following brief introductions the permit and its requirements were reviewed.

The importance of timely reporting of periodic monitoring, procedure reviews and incidents and accidents was stressed. A late report is often a symptom of a system that is not truly robust.

NRW will be pleased to offer help and assistance where appropriate, but we cannot do so if we are not aware of any difficulties.

There was a brief inspection of the effluent treatment plant (ETP) to see the recently refurbished sand filter. CT are planning further upgrades to the ETP as part of the factory improvements mentioned below. The issue of whether or not the filtercake should be classified as hazardous waste was discussed. CT have been using the WAC test to determine how the waste should be classified. This test should only be used to determine whether or not a waste can be sent to landfill; it must not be used to determine a waste's hazardous properties. CT were advised to carry out a full analysis on the filtercake and then, using CLP Table 3.1 and WM3, calculate if the waste is hazardous. The limiting factor is likely to be the concentration of nickel hydroxide, calculated as a percentage of the actual (wet) filtercake, as this has the most stringent limits.

It was very useful for me to meet Sarah so soon after her appointment.

It is very encouraging to note that CT are planning significant investment in this site over the next 18 months, which should improve product flow through the manufacturing process and increase business volumes.
