4. Details of our assessment

Solutia provided NRW with a Schedule 5 Part A Notification on 5th August 2021 in respect of the NOx monitoring result for Boiler 14 back-up unit. This had been operated for a period of 26 days. The permit requires monitoring of the back up boiler if it is operated for a continuous period of more than 14 days in any calendar year.

The Part B Notification was received on 3rd December 2021. The back up unit had been operated whilst Boiler 16 had a scheduled maintenance shutdown, however, during this time, unplanned repair work on Boiler 16 was required, this extended the operational time.

A NO_x measurement of 173mg/Nm³ was reported against the emission limit value of 150mg/Nm³ for release point A2.

Operation of the backup boiler ceased on 29th July 2021.

An uncertainty allowance of 20% can be applied to NO_x measurements. This brings the measured value to below the emission limit value.

On this basis a non-compliance has not been recorded.
