Liberty Steel had been granted permission to store up to 75 000 tonnes of coal for Uskmouth Power for a period of up to six months (Liberty Steel and Uskmouth Power are both owned by SIMEC). The intention was that the coal would be moved to Uskmouth within the timescale of this original permission (see CAR form EP38390GH/0234200). In late August it was advised that there had been delays in negotiating the movement of the coal with Network Rail and they therefore requested an extension to the original permission. This was granted (see CAR form EP3830GH/0247685).

Due to further delays primarily as a result of poor weather that led to damage of the road surface Liberty Steel requested a further extension (Email dated 17/12/2016). This CAR form confirms that NRW agree to an extension which takes the permission for storage up to 31st March 2016.

Liberty Steel and Uskmouth Power must endeavour to ensure that all coal is removed from Liberty Steel by 31st March 2016.

Liberty Steel must continue to manage the coal stocks in accordance with the previously agreed Management Plan and respond to any issues that may arise in a timely and effective manner.
