The following comments are provided:

Action (2) The final version of the Water Management Plan has been provided. There is specific reference to the procedure for removal of ground water from the site cellars and pits. This is acceptable and will avoid the potential for contaminated water being discharged directly to surface water drains. All relevant staff should be made aware of this procedure. Action complete.

Action (4) A copy of the Fire Prevention and Mitigation Plan has been provided. This is a detailed document that should ensure the effective management of stored waste and control of the potential environmental impacts. Aspects of the plan will be audited as part of subsequent NRW site audits. Action complete.
