Liberty Steel Newport (LSN) have requested temporary permission to receive and store EAF dust from Celsa Manufacturing (UK) Ltd, pending its transfer for recovery overseas. This request has arisen as the normal permitted site that stores Celsa's EAF dust (Cargo Services) has had to move its operation at short notice and the proposed replacement site (Birdport) awaits a permit.

LSN already have a permit that covers storage of their own generated EAF dust and the material being produced by Celsa is the same.

This CAR form grants permission for LSN to receive EAF dust in sealed bulk bags for storage on site pending, transfer under TFS for recovery, or, movement to Cargo Services's new site when permitted. An area of LSN's site suitable for short term EAF dust storage has been identified (Email to NRW dated 13th April 2016). Such permission is temporary and granted for a four month period from the date of this CAR form. The expectation is that prior to a four month period elapsing Cargo Services will have a new permitted facility that will receive EAF dust direct from Celsa.

LSN must ensure that the storage of EAF dust received from Celsa/Cargo Services is managed such that there is no environmental impact. All bags received must be sealed and undamaged. Notification must be provided to NRW when removal of the stored EAF dust is complete. **Action: LSN.**
