Liberty Steel Newport provided on 15th November 2017 an Action Plan for the removal of stored baled RDF from the installation to Trecatti Landfill for disposal. The RDF has been stored on site for a period of time that now exceeds the permitted storage duration.

NRW accept the Plan and the described working methodology. Liberty Steel should ensure that this is completed in accordance with the proposed timescale of completion by w/e Friday 16th March 2018.

Liberty Steel are required to provide an update on progress at two weekly intervals from the period commencing Monday 13th November 2017. These updates should confirm;

- Quantity of RDF removed during the previous two weeks
- Total RDF removed since commencement of work
- RDF remaining on site

The first two weekly update is due by Friday 30th November 2017 for the two week period 13th to 26th November 2017.

It will be the intention to inspect the operations during the course of the work.

Liberty should be aware that the opening of RDF bales may lead to the release of odour. This may necessitate additional measures to be adopted in order to maintain compliance with the existing permit conditions.
