Purpose of the meeting was to discuss the Carbon Monoxide (CO) spikes that Continuous Emission Monitoring (CEMs) data logger had captured since 8 April 2017 when the CO value was 328mg/m³.

The meeting reviewed graphs (2 of) that had referenced data from LINE 1 on 2 MAY 2017. The x axis unit of time and ranged from 1409H to 1649H in 10 minute intervals and the y axis unit was mg/m³ ranging from 0 to 200mg/m³ in 20 mg/m³ intervals.

The graphs illustrated the parameters of CO, NO and % v/v for H₂O and O₂.

Discussion concerned the run up to the CO at 1507H (where CO spike did materialise) and further explored the trends around 1614H (where a CO didn't materialise).

SH and SD offered to undertake a more indepth analysis of the raw data of 2 MAY 2107 (inc. what actions were undertaken by the control room to prevent the CO spike from occurring at 1614H).
