Viridor Site visit

Fiona Bussell - Viridor

Gathered in the visitor's car park, then went into the reception area where we were met by Fiona Bussell (HSE Manager), after signing in we went upstairs for more introductions and an induction session.

Fiona Bussell talked about the . . .

Impact of Prosiect Gwyrdd and other contracts

- Build and commissioning phases.
- Cost of build and duration of operations.
- Types of waste imported and by products of burning waste (electricity, IBA, and APCr)

After a brief Q and A session we prepared for the tour of site (boots, hi viz, safety specs and gloves).

After leaving the meeting room we initially went to the CONTROL ROOM. Watched lorries tipping into waste bunker and the grab transferring waste to the grate.

Group appreciated no picking line present as all incoming waste was considered to pre- sorted. Duty of each local authority to collect recyclables.

Upon leaving CONTROL ROOM we walked along walk ways passing the fire water tank and stopped at the viewing point of the grate.

Continued along gantries to view scale of internal infrastructure (2 lines of boilers and heat exchangers and steam pipework).

Examined and discussed the abatement and CEMs automatic samplers.

Descended the walk ways and passed the bulk metal separators and walked beside the conveyor belts that transferred the IBA in to the IBA STORAGE HALL. When inside the IBA STORAGE HALL the group saw the use of the overband magnet that captured the smaller sized ferrous metal. IBA moved into one bay ferrous dropped below the overband magnet.

Left the IBA STORAGE HALL and passed the LIME and ACTIVATED CARBON SILOS used within the abatement process to scrub gaseous before release.

Exited the building and passed the SETTLEMENT LAGOON and viewed the weighbridge cabin.

After stopping at the location where water discharge to sewer occurred we walked around the building under the HEAT EXCHANGER superstructure and noted the earth bund and security fencing.

Whilst standing in the doorway the group looked inside the TURBINE HALL.

Continued walk around the building to the base of the STACK and considered the proximity of neighbours and confounding factors that exist.

Fiona Bussell answered additional concluding questions and was given a vote of thanks.

The site was fully operation during the whole time of the site tour.
