NRW discussed this elevated (ELV) and that a high volume of plastic being received at that time was the cause. We acknowledge your detailed responses on the 18th January 2018 and 25th February 2018.

Based on these responses we are satisfied that this is an unusual one off event and that the measures you have implemented to prevent a re-occurrence are satisfactory. Therefore on this occasion a CCS4 - A non compliance which has no potential environmental effect has been issued for this event
