### **Introductory note**

**This introductory note does not form a part of the notice**

The following notice gives notice of the variation of an environmental permit.

This is an administrative variation of a tier 3 bespoke environmental permit. This variation is to change the monitoring frequencies in Table S3.1 - Point source emissions to air, for Dioxins / furans and Hydrogen fluoride from quarterly to 6 monthly to reflect the monitoring requirements of Table S3.4.

Table S1.3 has also been amended to reinstate improvement conditions: IC1, IC2, IC3, and IC4. The improvement conditions have been reinserted to correct an administrative error in EPR/LP3030XA/V003 by Natural Resources Wales.
