Forms **A1 and A2, Emissions to Air, S1, Emissions to Sewer and W1, Emissions to Water**, for April to June 2016, were received on 1st August 2016.

All emissions were within their respective emission limit values.

All the reports are accepted.

The **Groundwater Monitoring Report for 2016** was received on 14th July 2016.

The lead (Pb) concentration in Borehole (BH) 1 was the lowest since 2008, but still exceeds the Environmental Quality Standard (EQS). The pH is within the EQS.

BH3/12 had the highest concentration of all the boreholes sampled and the highest at this location since 2007. It is an abnormally high reading for this BH. The pH is within the EQS.

The Pb concentrations in BH 4, 6 and 8 are all less than the EQS and the pH in these locations is also within the EQS.

Pb concentration in BH 9 has been rising since 2013 and has exceeded the EQS for the first time in 2016. The pH is within the EQS.

As the concentrations of Pb in some BHs were either abnormally high or showing a tendency to increase, EnerSys propose re-testing in December 2016. In the meantime EnerSys are strongly advised to investigate the area around Cell 1B to see if there is any reason for the increasing Pb concentrations around this area.
