Annual reporting forms for 2017, PI1, Performance Indicators, E1, Energy Usage, WU1 Water Usage and R1, Waste Disposal and Recovery, were received on 31st January 2018.

Quarterly reporting forms for the period 1st October to 31st December 2017 for Emissions to Air, A1, Emissions to Air, A2, Emissions to Water, W1 and Emissions to Sewer, S1, were received on 31st January 2018.

All the reports are accepted.

Production 2017

This increased by 18%, compared with 2016.

Energy Usage 2017

Energy use per tonne of production fell by 15% in 2017, but CO₂ releases increased slightly.

Water Usage 2017

Water use per tonne of production was 29% less than in 2016.

Waste Disposal and Recovery 2017

The total amount of waste generated per tonne of production was 4% less than in 2016. The amount of waste disposed of per tonne of production fell by 12.5% compared with 2016 and the amount of waste recovered per tonne of production was 3% less than in 2016.

Performance Indicators 2017

Energy use was 1697kWh/tonne; water use was 0.82m³/tonne; waste disposed was 0.007T/tonne; waste recovered was 0.127T/tonne.

The mass of lead released to the environment was almost 18% less than in 2016.

Despite production volumes increasing by almost 20% in 2017, EnerSys have reduced their use of resources and the amount of waste generated from their operations; a significant achievement.

A1, Emissions to Air, 1st October to 31st December 2017

Emissions to air from all emission points were less than their respective emission limit values (ELVs).

A2, Emissions to Air, 1st October to 31st December 2017

Total emissions from all emission points were lower than in 2016.

W1, Emissions to Water 1st October to 31st December 2017

Lead emissions were all less than the ELV.

S1, Emissions to Sewer 1st October to 31st December 2017

All parameters were within their respective ELVs.
