The Annual Environmental Report for 2017 was received on 27th February 2018. Natural Resources Wales have agreed that EnerSys will submit this report by 28th February each year, rather than 31st January as required by the permit.

The report is accepted.

Six environmental business objectives were set, of which five have been achieved or are in progress.

The EHS department merger with the quality department has been reversed; adequate resources for environmental matters have been maintained. The number of employees across the two sites rose by more than 9% in 2017. Training and the commitment to it continues.

There are clear communication levels and routes with regular meetings at the appropriate level to rectify any problems. The performance of the Environmental Management System (EMS) is reviewed at regular plant meetings which are attended by senior management. The EMS itself is reviewed annually and is now compliant with ISO14001:2015.

The EPR permit was varied in 2017 as a result of the publication of the BAT conclusions for the non-ferrous metals sector. Two improvement conditions were added, both of which are in progress. Form A2 has been removed from the annual reporting requirements.

The mass release of lead to air continues to decline. There were two breaches of the emission limit value (ELV) for lead emissions to air under the previous permit conditions.

The ambient lead concentration downstream of the site is ~half of the National Air Quality Objective (NAQO) and is consistent with previous years. The value upstream is ~10% of the NAQO.

Emissions to water and sewer were both within the relevant ELVs.

Waste disposed of and total waste generated, both per tonne of production, show a downward trend. Water usage shows a continuing reduction; the savings measures already implemented are obviously effective.

Energy use is also reducing, but this is more prone to fluctuations in production.

Groundwater is monitored annually and the 10 yearly soil sampling was completed in November 2017. The results will be available by April 2018.

Targets for 2018 include reducing fugitive emissions across the site, reductions in raw materials use, waste generation and energy consumption and confirming that the EMS is ISO14001:2015 compliant.

This report is succinct, well written and comprehensive, with achievements against 2017 targets clearly explained. It sets out sensible, realistic targets for 2017 and 2018 and demonstrates an on-going reduction in resource use since 2012. EnerSys are to be congratulated on the quality of this report and for their obvious commitment to minimising their impact on the environment whilst maintaining a viable business.
