4. Details of our assessment

According to the information supplied by DCWW, a temporary power loss occurred to the sewage pumping station on 12/10/20 due to work carried out by Western Power Distribution. WPD had set up an incorrect voltage standby generator on site that resulted in the pumps at the SPS not working. As the pumps were not working, this caused high levels in the wet well at the SPS and sewage to back up to the nearby Farmers Road CSO which caused sewage to discharge to the river. Minor discoloration was seen around the outfall that discharged.

Farmers road CSO is only permitted to discharge under the conditions stipulated by permit condition 2.3.1 ie during wet weather. Therefore, this condition was breached when the discharge occurred on 12/10/20.
