### 4. Details of our assessment

Angharad Clark and Linda Warrick attended Carew Car Dismantlers, Permit EPR/RP3598FN on 3rd November 2021.

No mud was observed at or near the entrance to the site.

All vehicles are depolluted in a shed with an intact concrete pad.

Car batteries are stored in containers in a shed.

Oils are stored in a bunded container in a shed.

An application to extend the permitted area has been submitted, Leeann Jones mentioned that this had been submitted some time ago. The application had been duly made and is being assessed.

### **Hazardous Waste**

There have been a number of areas that require improvement with regards waste activities involving Directly Applicable Legislation, namely the Hazardous Waste Regulations 2005 and the Duty of Care Regulations, as detailed in Section 34 of the EPA 1990. These are listed below:

Batteries 16 06 01\* are consigned to Sims in Neath using the correct code, however there were no quantities on Part B and the premises code CAG263 had expired in 2017.

Oils: The Consignment Notes provided show that the waste oils (13 02 05\*) leaving your site are being consigned to Slickers on Newport. There were 2 notes for this waste stream for movements in 2019 and 2020. The correct CN code was used on both of these notes CAK733.

There were significant numbers of consignments notes for Catalytic Convertors (16 01 21\*). These had been moved to a number of sites since 2018, name Bayliss, JWB, EBL and Newbury Metals. Some had invalid consignment note codes.

Waste going to England (EBL and Newbury Metals) had incorrect consignment note codes. The registered premises code in Part A for the producer should be used.

Consignee Returns show returns for Slickers and Simms (however some of the Simms movements used then expired CN code of CAG263). There were no consignee returns for Bayliss, EBL, JWB and Newbury Metals.
