4. Details of our assessment

Angharad Clark and Linda Warrick attended Waterston Car Breakers, EPR/WP3298FZ, on 3rd November 2021.

No mud was visible near entrance or on road.

Depollution of vehicles is carried out inside a shed. Concrete pad was intact.

Car batteries and oil were also stored inside containers on the shed.
The site is served by a sealed drainage system.

Hazardous Waste

There have been a number of areas that require improvement with regards waste activity involving Directly Applicable Legislation, namely the Hazardous Waste Regulations 2005 and the Duty of Care Regulation, as detailed in Section 34 of the EPA 1990. These are listed below:

Batteries 16 06 01* are consigned to Sims in Neath using the correct code.

Oils: The consignment notes provided show that the waste oils (13 02 05*) leaving your site are being consigned to Slickers in Newport.

There are no consignment notes for Catalytic Convertors (16 02 21*) and after further enquiries it was established that Catalytic Convertors have previously been moved to an illegal site in England. Please ensure Duty of Care checks are made prior to waste being moved onward.

Four of the five notes audited had no quantity recorded.

Consignee returns show that there have been limited movement of waste from the site but consignment notes audited do not correlate with the returns data. Please ensure consignee return data is up to date.

These above issues fit into the directly applied legislation category which links to Condition 1.1.1 of the site Environmental Management System. Procedures are required that will ensure these issues are addressed along with procedures to ensure these checks are made prior to waste leaving your site.
