Main focus of this site meeting was to discuss the recent dust complaints.

We discussed the events on the 28th July 2017 where there seemed to be an unforeseen kiln failure which resulted in a fugitive dust emission that impacted on the local residents. As this emission caused an environmental impact NRW on this occasion have issued a Permit non-compliance.

We discussed the dust complaints from the beginning of August, however based on the evidence and circumstances around this event NRW have not issued any Permit non-compliance. The reasons for this judgement is that the dust on this occasions was black dark be a black substance and could be attributed to other sources and activities in the area. NRW have discussed these issues with other sites we regulate in Aberthaw.

Dust suppression bowser has now increased to 7 days a week and the car cleaning of resident's cars is continuing.

The site plans to repair another cooler tube in September when the site shuts down. This will be result in seven out of the eight cooler tubes have now been repaired.

Tarmac confirmed that they are reviewing and rolling out environmental awareness training, all staff on site will receive this training that will focus on working culture and how to reduce environmental pollution (dust). Tarmac also confirmed significant capex has been agreed for site improvements 2017/2018 that will further reduce fugitive emissions.

Tarmac confirmed plans to reduce the clean stone stock pile that is located closest to the residents.

Discussed AST and particulates monitoring below 10mg/m³, plans to re-bag the filters are re-sample. Further discussion after test has taken place.
