NRW are issuing a Permit Non-compliance for this elevated Emission Limit Value (CCS4) - A Non-compliance at a regulated site that cannot foreseeably have any impact on the environment. We also acknowledge in your correspondence that the January 2018 result for this Emission point is 30mg/l and the reason for the elevated result in December was due to periods of heavy rainfall.

These circumstances have been reflected in the non-compliance issued on this occasion.
