Tata provided a Schedule 1 Notification to NRW on 30th November 2017 in respect of the cadmium content in the release to water at W1, as sampled on 7th October 2017.

A level of 0.061mg/l was reported against the limit of 0.05mg/l.

It was noted that all subsequent monitoring results have been below the limit and there had no previous recorded exceedances.

There was no know reason for the raised level.

The permit states that the limit shall be complied with if 95% of all weekly representative spot samples during a rolling half year period do not exceed the limit value and the peak spot sample value does not exceed 1.5 times the limit value.

No non-compliance has therefore been recorded.
