Tata provided a Schedule 1 Notification Part A to NRW on 4th January 2017 in respect of an exceedance of the Oil in water ELV of 5mg/l at W1, recorded on 29th December 2016. A value of 12.5 mg/l was recorded for the first sample and 63.3 mg/l on a second sample, however, there had been no visual indication of oil on the lagoon surface. A Part B was provided on 1st March 2017.

The non-compliance has been categorised as a Cat 4 on the basis that there was no detectable environmental impact and there was a strong possibility that the determined values were erroneous.
