Fugitive Emissions - The risk management in place for the identified sources of fugitive emissions remains appropriate. Tata should continue to ensure the abatement measures continue to be applied in an efficient and effective manner and any significant changes to operations are assessed for their impact upon fugitive emissions

EMS - It is accepted that as a direct result of mothballing target setting has been difficult together with the ability to make on going improvements. However, the on going achievements in respect of waste management and TSSP UK legionella group are commendable.

Waste Annual Report - the report is sufficiently detailed and the metrics reported enable a valuable year on year assessment of performance. Where detailed comment is provided in respect of specific process waste streams it should be ensured that these are easy to cross check with the wastes reported in Form R1.
