The following notice gives notice of the variation and consolidation of an environmental permit.

This variation will allow annual capacity of the plant to increase from 185,000t/yr to 225,000t/yr. There are no planned changes to the product range, raw materials used or processes. Increase in capacity will be achieved by reducing down time between batches and improving processes to facilitate higher throughput rates.

There will be no new emission points as a result of this variation.
